COMES NOW the Applicant, MESA EXPLORATION COMPANY, INC., and alleges and states:

1. That heretofore, on the 17th day of October, 2019, the Applicant filed in this cause its Application to be granted an exception or variance to OAC 165:10-5-6(b)(2)(F) by being allowed to run a Radioactive Tracer Survey ("RATS"), in lieu of a Mechanical Integrity Test, for the Ward #6 Enhanced Recovery Injection Well located in the W/2 W/2 SE/4 SE/4 of Section 22, Township 6 North, Range 3 East, Pottawatomie County, Oklahoma. The name and address of each party entitled to notice of this Application for Emergency Order are as shown on Exhibit "A," attached hereto and made a part hereof.

2. It is necessary for the Applicant to run the RATS in order to begin injecting produced water in the Ward #6 Enhanced Recovery Injection Well pursuant to the parameters of Order No. 696459. Applicant has oil and gas leases which are in their secondary term which need to be produced in order to maintain the validity of said oil and gas leases and comply with an OCC plug or produce order all of which will prevent financial loss to the company. That Applicant will suffer financial loss unless it is authorized to run the RATS prior to the entry of a final order in this cause.

3. LEGAL AUTHORITY: OAC 165:5-9-3.

WHEREFORE, Applicant prays that this Commission issue an order authorizing the running of the RATS in the Ward #6 Enhanced Recovery Injection Well prior to a final determination in this cause.





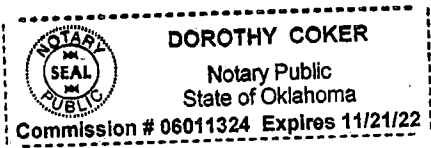
