**ORDER GRANTING MOTION FOR EXTENSION OF TIME**

The Motion for Extension of Time came on for hearing before an Administrative Law Judge of the Oklahoma Corporation Commission, at 9:00 a.m. on the 15th day of October, 2019, Eastern Regional Office, 440 South Houston, Tulsa, Oklahoma 74127 pursuant to notice given as required by law and the rules of this Commission.

At hearing Ron M. Barnes and Grayson Barnes, Attorneys, appeared for the Movant/Applicant. No protests were announced and the motion was heard uncontested.

At hearing the motion was amended to extend one of the two requested wells as the other has been drilled and completed.

Movant/Applicant has been unable to commence the drilling of the wells under the time provided in **Order No. 685323**. FourPoint Energy, LLC has twice attempted to drill the remaining well but lost both attempts at the surface casing point. FourPoint Energy, LLC has plans for a third attempt.

Therefore, after reviewing the argument of counsel, the Administrative Law Judge recommended the granting of the Motion.


**ORDER**




