**ORDER GRANTING MOTION FOR  
EXTENSION OF TIME**

The Motion for Extension of Time came on for hearing before an Administrative Law Judge of the Oklahoma Corporation Commission, at 9:00 a.m. on the 29th day of October, 2019, Eastern Regional Office, 440 South Houston, Tulsa, Oklahoma 74127 pursuant to notice given as required by law and the rules of this Commission.

At hearing Ron M. Barnes and Grayson Barnes, Attorneys, appeared for the Movant, Cimarex Energy Co. The Motion for Extension of Time was not protested and the motion was heard uncontested.

The evidence revealed that the Movant intends to drill the well, but due to rig availability has been unable to commence the drilling of the unit well under the time provided in **Order No. 686877**.

Therefore, after reviewing the argument of counsel, the Administrative Law Judge recommended the granting of the Motion.

IT IS, THEREFORE, ORDERED by the Corporation Commission of the State of Oklahoma as follows:

That the time for the drilling of the well under the provisions of **Order No. 686877** be extended for an additional one year or until November 19, 2020. All other provisions of **Order No. 686877** shall remain in full force and effect.
