IT IS THEREFORE, ORDERED by the Corporation Commission of the State of Oklahoma as follows:


That this cause be, and the same is hereby dismissed without prejudice to the filing of a new Application.



That the authorization and permission granted in Interim Order No. 695261 is hereby terminated effective the date of this Order Dismissing Cause.


